



## **Desnitsky Centre Ltd (DC) GDPR policy**

The Desnitsky Centre Ltd ('DC', 'the firm') knows that you care how information about you is used and shared. This Privacy Policy explains what information of yours will be collected by DC when you use our services, how the information will be used, and how you can control the collection, correction and/or deletion of information. We will not use or share your information with anyone except as described in this Privacy Policy.

### **Information We Collect**

Information provided to us, such as names and e-mail addresses, may be retained. If you correspond with us by email, we may retain the content of your email messages, your email address and our responses. We may also retain any written information provided to us by post.

Third Party Services: DC uses third party services, such as law firms, to assist us and allow the firm to perform its services.

### **How We Use Your Information**

We use the personal information you submit to operate, maintain, and provide to you the features and functionality of our services.

By providing DC your email address, you consent to our using the email address to send you DC related notices, including any notices required by law, in lieu of communication by postal mail. We may use your email address to send you other messages, such as newsletters, or other information relating to DC activities, including new projects, events and developments. If you do not want to receive such email messages, you may opt out at DC's unsubscribe page or notify the firm in writing to our Brook Street address.

Following termination or deactivation of your account, DC may retain your profile information and user content for a reasonable time for archival purposes. Furthermore, DC may retain and continue to use indefinitely all information (including user content) contained in your communications to others after termination.

### **How We Share Your Information**

Personally, Identifiable Information: DC will not rent or sell your personally identifiable information to others. DC may share your personally identifiable information with third parties. If we do this, such third parties' use of your information will be bound by this Privacy Policy. We may store personal information in locations outside the direct control of DC (for instance, on servers or databases co-located with hosting providers).

Except as otherwise described in this Privacy Policy, DC will not disclose personal information to any third party unless required to do so by law or subpoena or if we believe that such action is necessary to (a) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (b) to enforce this policy, take precautions against liability, to investigate and defend ourselves against any third-party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (c) to exercise or protect the rights, property, or personal safety, our users or others.

## **How We Protect Your Information**

DC cares about the integrity and security of your personal information. We cannot, however, ensure or warrant the security of any information you transmit to DC or guarantee that your information on the service may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards.

Your privacy may also be affected by changes to the functionality of third-party providers. DC is not responsible for the functionality or security measures of any third party.

To protect your privacy and security, we take reasonable steps to verify your identity before granting you access to your account. You are responsible for maintaining the secrecy to your communications from DC, at all times.

## **Compromise of Personal Information**

In the event that personal information is compromised as a result of a breach of security, DC will promptly notify those persons whose personal information has been compromised, in accordance with the notification procedures set forth in this Privacy Policy, or as otherwise required by applicable law.

## **Your Choices About Your Information**

You may, of course, decline to submit personally identifiable information, in which case DC may not be able to provide certain services to you. ## **Children's Privacy**
